

TAREN POINT BOWLING CLUB

Win a trip to New York

1. This competition (“Competition”) is conducted by Taren Point Bowling Club, ABN 26 000 105 948, of 203 Holt Road, Taren Point, NSW, 2229 (“Promoter”). Phone number (02) 9522 8111.
2. Entry into the Competition constitutes acceptance of these conditions. All entry instructions and prize information published by the Promoter form part of these conditions.
3. Only open to “Eligible Entrants”. An Eligible Entrant is an individual who is an Australian resident as at time of entry, including any: (i) current member of Taren Point Bowling Club; (ii) person over 18 years of age. This excludes any: (i) employee of the Promoter, Director or any of their agencies associated with the Competition; (ii) employee of Taren Point Bowling Club, ABN 26 000 105 948; (iii) spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iv) person who the Promoter has previously notified is not permitted to enter the Promoter’s competitions.
4. Promotional period: 9:00 AEST Monday 10th August 2019 to 18:30 AEST Saturday 14th September 2019.
5. Entry tickets for the draw will be automatically issued to members who:
 - a) Insert their current membership card into the membership swipe terminal and swipe. Limited to one (1) entry ticket per day.
 - b) Insert their current membership card into the membership swipe terminal and purchase entry tickets at the value of 4 points per ticket. Unlimited amount of entry tickets can be purchased per day.
 - c) Spend an accumulated amount of \$30.00 at Taren Point Bowling Club’s bar or bistro. Taren Point Bowling Club encourages responsible service of alcohol.
6. Entry tickets generated from members who (a) insert their current membership card into the membership swipe terminal and (b) purchase tickets with their membership points (c) spend an accumulated amount of \$30.00 within Taren Point Bowling Club bar & bistro will automatically be given an entry ticket. Entry tickets will be printed with the current date, member’s name and membership number from the approved ticket splitter.

7. There will be a total of Seven (7) draw conducted:
 - a) Saturday 24 August 2019 at 19:00 AEST – 1 Finalist Draw
 - b) Saturday 31 August 2019 at 19:00 AEST – 1 Finalist Draw
 - c) Saturday 7 September 2019 at 19:00 AEST – 1 Finalist Draw
 - d) Saturday 14 September 2019 at 19:00 AEST – 3 Finalist Draws
 - e) Saturday 14 September 2019 at 19:30 AEST – 1 Major Draw
8. Contestants must be present at Taren Point Bowling Club and once drawn make themselves known to the person responsible for conducting the promotion before they are permitted to accept the prize.
9. All participating members will receive entry tickets into all draws. All tickets will be dated, include contestant's details and will be entered into the draw.
10. All Seven (7) draws will be conducted by a Taren Point Bowling Club employee or promotional staff member.
11. Entries are not transferable and finalists from the weekly draws must be present at the final.
12. Every Saturday during the promotional period from 7pm an eligible entry will be manually drawn from the barrel:
 - a) The members name will be announced 3 times and given 3 minutes to present themselves to the designated promotion staff member located at the promotional barrel to be a finalist for the final draw on Saturday 14 September 2019.
 - b) If the member does not present themselves to the designated promotion staff member within the 3 minute time period then another eligible entry will be drawn every 15 minutes until a member is present.
 - c) Once an eligible weekly entrant has been found no more draws will take place after this draw.
 - d) If no winner is found during the weekly draws an extra draw will be added to the final draw held on Saturday 14 September 2019 from 6.30pm.
 - e) On Saturday 14 September 2019 from 6.30pm, there will be a total of Six (6) eligible finalists for the final draw. These Six (6) finalists will be made up of the finalists drawn from the preceding weekly draws and final draw as outlined in 10(a) – 10(d).
 - f) Once all the eligible finalists have been drawn on Saturday 14 September 2019 the major draw will take place. Finalists will then select a boarding pass in the order they were drawn. The boarding pass will be printed with a number.

- g) Taren Point Bowling Club staff member will activate a random number generator which will generate a number between one (1) and six (6). The winner will have the matching number from the random number generator which correlates with the number on the boarding pass.
- h) The eligible finalists will then be asked to present their boarding pass to Taren Point Bowling Club staff member for verification.
- i) The remaining 5 final entrants will each win 2000 Member Rewards Points.
- j) Final draw on Saturday 14 September 2019 from 6.30pm.

13. One entry will be drawn per nominated draw time and the winners name will be announced over the club's PA system and the member will have 4 minutes to come forward to accept their prize. Members must be on club premises at the time of the draws to participate.

14. Members are required to present their current financial Taren Point Bowling Club membership card to the person responsible for conducting the promotion.
